## summary

**T**he *Executive Course in Art&Law*  
is structured in three main modules.

1. The first module is devoted to explaining the main legal and ethical features of the **international circulation of cultural objects**. Taking for granted that cultural objects hold significant historical, artistic, and cultural value and are often considered important national treasures from which they originate, the international circulation of cultural objects appears nowadays more and more relevant. Indeed, it refers to the movement of artistic, historical, or archaeological artefacts across national borders, which can occur through various means, such as legal trade, donations, loans, or illicit activities like theft and smuggling.
2. The second one is dedicated to **art, new trends and technologies** and it wants to underline how art, like any other field, is influenced by technological advancements and changing trends. In recent years, indeed, several new trends and technologies have emerged that have had a significant impact on the art world, such as digital art, NFTs (Non-Fungible Tokens), generative art, virtual reality (VR) and augmented reality (AR). As technology continues to evolve, the future and present operators in the sector of art can expect further advancements that will shape the way art is created, exhibited, and experienced.
3. The third module is dedicated to **intellectual property (IP) and artificial intelligence (AI)** because IP and AI intersect in the realm of art in several ways. It is evident that AI has been increasingly used as a tool in the creation, reproduction, and distribution of artistic works, raising important questions about ownership, authorship, and protection of these AI-generated creations, especially considering copyright, patents and trade secrets, moral rights, AI as a tool, fair use and transformative works, and licensing and commercialization.

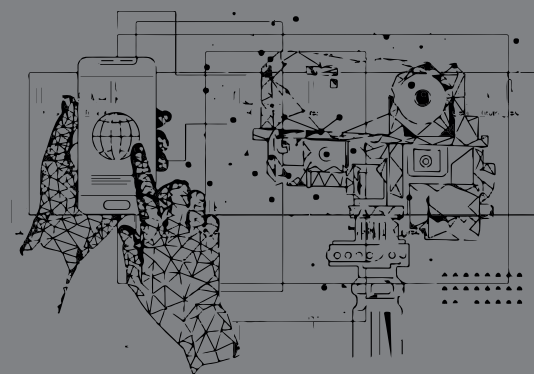

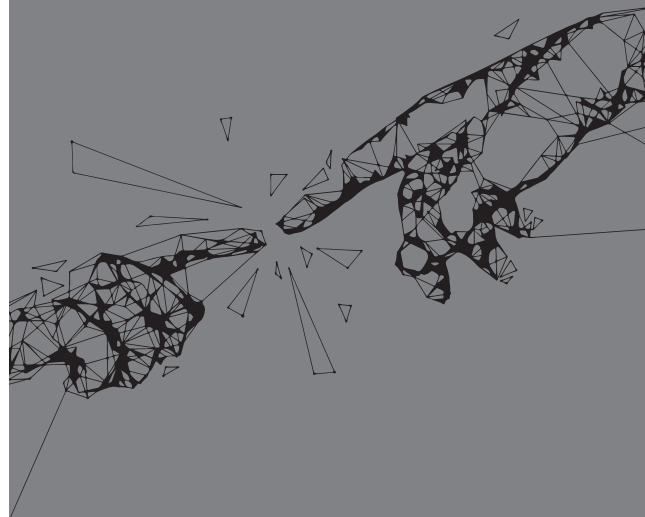

**Marc-André Renold**, Dr. iur., LL.M. (Yale), studied at the Universities of Geneva and Basel in Switzerland and at Yale University in the USA.

Marc-André Renold is full Professor of art and cultural heritage law at the University of Geneva and the Director of its Art-Law Centre. Since March 2012 he holds the UNESCO Chair in international cultural heritage law at the University of Geneva. Among the achievements of the UNESCO Chair, the data base ArThemis - reviewing more than 150 cases of dispute resolution in the cultural heritage sector - should be mentioned.

Marc-André is also Attorney-at-law, Member of the Geneva Bar, and he practices in the fields of art and cultural heritage law, intellectual property and public and private international law.

He is the author or co-author of many publications in the field of international and comparative art and cultural heritage law. He has been, since its inception, an editor of the "Studies in Art Law" series (27 volumes published to date).

**Arianna Visconti**, PhD in Italian and Comparative Criminal Law (2008), is Associate Professor in Business Criminal Law in the Università Cattolica del Sacro Cuore of Milan.

She is senior member of ASGP - Alta Scuola "Federico Stella" sulla Giustizia Penale / "Federico Stella" Graduate School of Criminal Justice (formerly CSGP - "Federico Stella" Centre for Research on Criminal Justice and Policy) in the same University, and coordinates its research groups on offences against cultural heritage (she edited, with S. Manacorda, Beni culturali e sistema penale, Vita e Pensiero, 2013, and Protecting Cultural Heritage as a Common Good of Humanity: A Challenge for Criminal Justice, ISPAC, 2014) and on law and literature (she is editor, with G. Forti and C. Mazzucato, of Giustizia e letteratura I, Vita e Pensiero, 2012, Giustizia e letteratura II, Vita e Pensiero, 2014, and Giustizia e letteratura III, Vita e Pensiero, 2016, and, with G. Forti, C. Mazzucato and A. provera, of L'ombra delle 'colonne infami'. La letteratura e l'ingiustizia del capro espiatorio, Vita e Pensiero, 2022).

Her other publications and studies cover defamation law, legal protection of reputation and 'reputational sanctions', online disinformation, theory of punishment, white-collar and organizational crimes, bribery, corruption and offences against Public Administration, corporate violence (she coordinated, with G. Forti, C. Mazzucato and S. Giavazzi, the EU-funded international project on "Victims and Corporations. Implementation of Directive 2012/29/EU for victims of corporate crimes and corporate violence", and is co-editor of Victims of Corporate Violence in the European Union: Challenges for Criminal Justice and Potentials for European Policy, Wolters Kluwer, 2018).

Since 2015 she also teaches 'Law and the Arts' in the Faculties of Economics and Arts & Philosophy, and since 2010 is appointed lecturer for the UCSC Higher School of Specialization in Legal Professions.

He is also lecturer at the Faculty of Law of the Université Catholique of Lille and at the Geneva Academy of International Humanitarian Law and Human Rights, and reporter for the International Law in Domestic Courts (ILDC) Oxford University Press project.

Alessandro is member of the editorial boards of the Italian Yearbook of International Law and of the Santander Art and Culture Law Review. He was consultant for the European Committee on Crime Problems (CDPC) of the Council of Europe for the revision of the Convention on Offences Relating to Cultural Property. Alessandro is the author of the book *The Settlement of International Cultural Heritage Disputes* (Oxford University Press, 2014) and several other publications in edited books and journals.

Currently, his main research areas cover international cultural heritage law, international law, international dispute settlement, transitional justice, international organizations, human rights and the law of international immunities

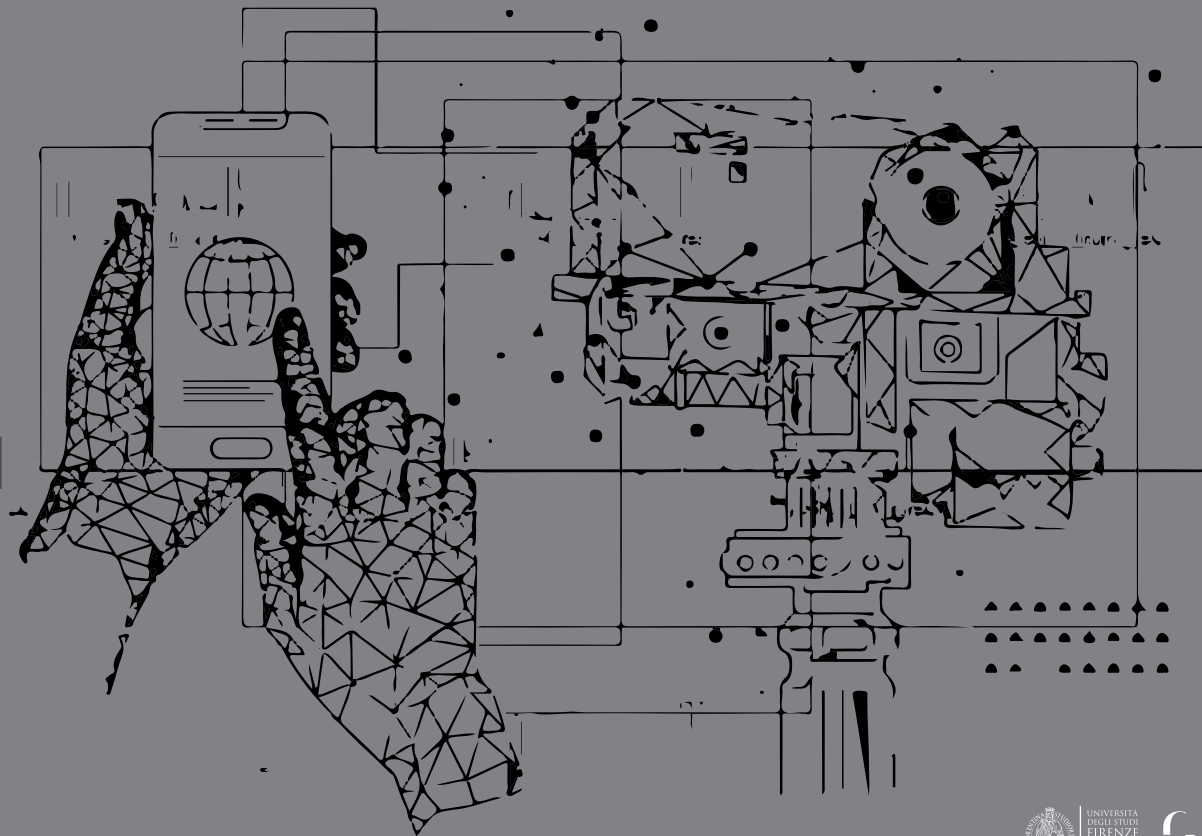

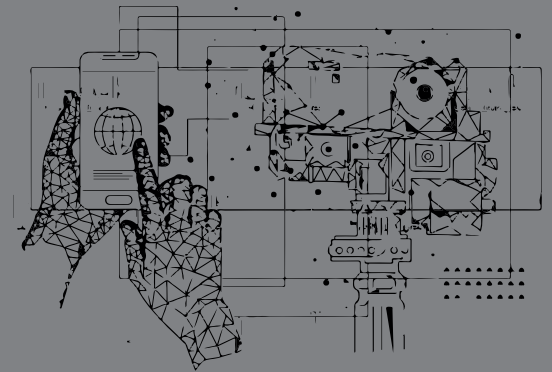

**Ettore Maria Lombardi** is Professor of Private Law and International Business Law at the University of Florence School of Law, where is also Director of the Executive Course on Alternative Investment, which is co-organized by the University of Florence School of Law and the Queen Mary University of London (Centre for Commercial Law Studies - CCLS), co-leading with Professor Rodrigo Olivares-Caminal of QMUL, and Director of the Mediation Advanced Course. He holds a J.D. (University of Florence), a J.C.L. (Pontifical University of Lateran), an LL.M. (Harvard Law School), and a Ph.D. (University of Florence). He is actually Visiting Professor at Birkbeck College - University of London (London, U.K.), Distinguished Scholar in Residence at St. John's University School of Law (New York City, U.S.A.), Research Fellow at BRICS Competition Law and Policy Center of the National Research Higher School of Economics (Moscow, Russia), Visiting Fellow of the Institute for Global Law, Economics and Finance (IGLEF) at the Centre for Commercial Law Studies, Queen Mary University of London (London, U.K.). On a more professional profiles, before opening his law firm, he was of counsel at DLA Piper (Rome-Milan), and id actually Member of the Arbitro Bancario Finanziario by appointment of Bank of Italy (Bologna, Italy) and President of the Supervisory Board on "231 Model" at Nuovo Pignone Holding S.p.A. (global holding of the Baker Hughes Company) (Florence, Italy). Prof. Lombardi has been teaching and researching in the most prestigious American, British and German universities. He is a lawyer in Italy and a member of various international legal associations. Prof. Lombardi has published three books with the most prestigious Italian editor (I. Warranty and Liability in the Sale of Consumer Goods, Giuffrè, Milano, 2010, p. XVI-504; II. The Financial Authorities' "Responsibilization": Models and Functions, ESI, Napoli, 2016, p. 1-430; III. The Impact of Digitalization on the Property: the Copyleft ESI, Napoli, 2020, p. 1-243; The Person, Conscience and Freedom, or About the Contractual Autopoiesis, Giuffrè, Milano, 2022, p. I-112) and more than fifty minor publications both in Italy and abroad.

**Auronda Scalera** plays a significant role in contemporary and digital art. She is an art curator, art consultant, and global ambassador for art and culture and lives between London, Dubai and the Metaverse.

She is the curator for the next Art Dubai digital 2024 and with Alfredo Cramerotti, - director of Mostyn contemporary art museum in the UK, Head of digital of AICA, advisor of the UK Government Art Collection, the British Council Visual Arts Acquisition Committee and the Italian Ministry of Culture 2022-24 -, she founded a curatorial duo about digital and new technologies.

The UK House of Lords invited her as expert witness to talk about art, culture and new technologies at the UK Parliament to be part of the first evidence session of a commission about Web3 and metaverse.

She organises webinars on Art and New technologies for the +Tate UK institutional network of museums. SkyTV / ClassCNBC interviewed her among others like Refik Anadol and Luciano Floridi, Oxford and Berkeley's professors on AI, art and museums. She is a speaker at many universities and events about art and the future.

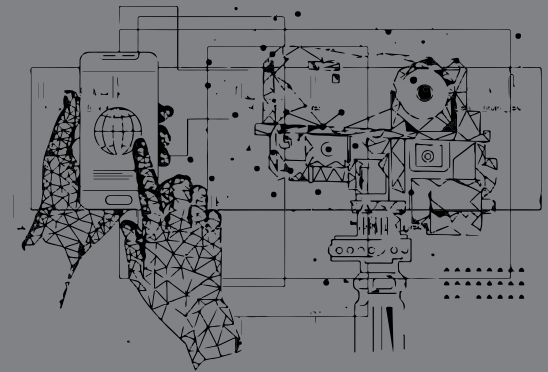

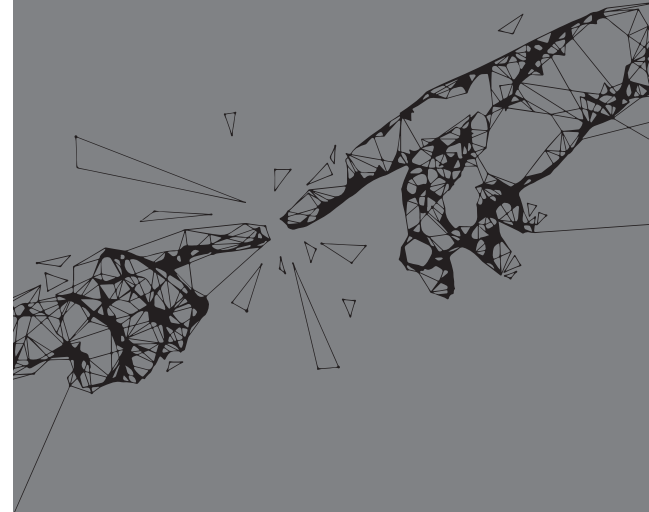
Prof. **Eleonora Rosati**

She is also an Italian-qualified lawyer (avvocato) and Of Counsel at Bird & Bird and holds visiting/guest professorships at Católica in Lisbon and CEPI in Strasbourg. A long-standing contributor to The IPKat and an Editor of the Journal of Intellectual Property Law & Practice (Oxford University Press), Eleonora is the author of several scholarly articles and books on IP issues, including - most recently - Copyright and the Court of Justice of the European Union (Oxford University Press, 2023), 2nd edition (1st edition published in 2019) and Copyright in the Digital Single Market - Article-by-Article Commentary to the Provisions of Directive 2019/790 (Oxford University Press:2021). She is also the editor of the Routledge Handbook of EU Copyright Law (Routledge:2021) and co-editor of Developments and Directions in Intellectual Property Law. Twenty Years of The IPKat (Oxford University Press:2023). Eleonora has been the recipient of accolades and prizes for her work in and impact on the IP field: in 2018, Managing Intellectual Property included her among the '50 Most Influential People in IP'; in 2020, World Intellectual Property Review listed her among its 'Influential Women in IP'; in 2022, she received the Adepi Award 2022 for her contribution to shaping the interpretation of IP law in Europe.

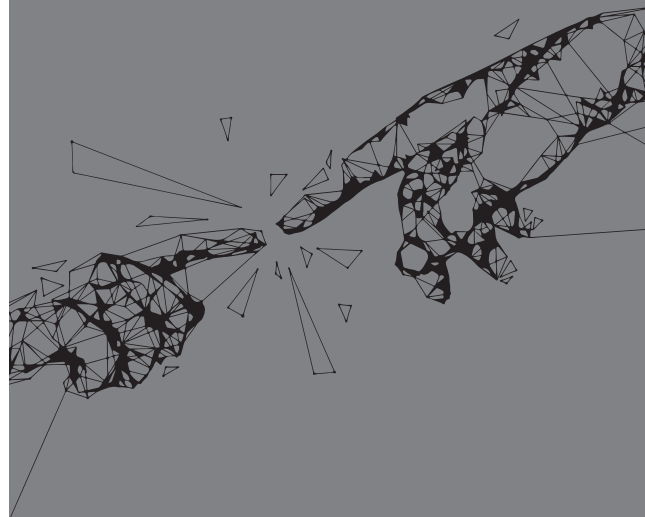
Prof. **Catherine Rogers**

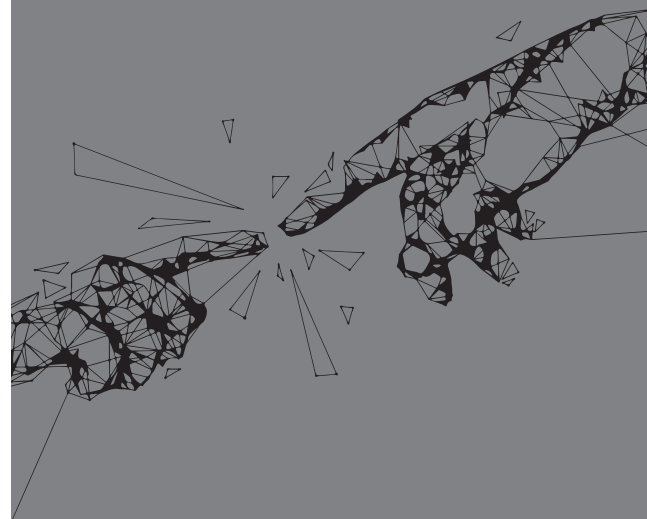

## AI and the image usage rights of public cultural heritage

speaker

Prof. **Antonio Tarasco**  
HEAD OF THE LEGISLATIVE OFFICE OF THE MINISTRY OF CULTURE

Professor **Antonio Tarasco** has been Head of the Legislative Office of the Ministry of Culture since November 2022.

He has been a manager of the Ministry of Culture since March 2010, where he dealt with recruitment and mobility, inspection controls, management and finance of museums, cultural institutes and foundations, copyright.

After obtaining the national scientific qualification of associate professor of Administrative Law (June 2015), he became a qualified full professor in the same discipline (March 2018), a judgment reconfirmed, unanimously by the commission, in June 2023.

Lawyer (2001), PhD at the Second University of Naples and specialist (with honors) in Administrative Law and Administration Science (2003), from 2007 to 2010 he was a researcher (permanently) in Administrative Law at the Faculty of Law of the “Federico II” University of Naples where he also taught Administrative Law, as aggregate professor, at the Faculty of Architecture and at the School of Specialization for the Legal Professions.

He teaches Legislation of cultural heritage in the master’s degree course in “Conservation and restoration of cultural heritage” of the Central Institute for the Restoration and Conservation of Archival and Librarian Heritage of the Ministry of Culture.

He is the author of over one hundred essays on public and administrative law on sources of law, cultural assets and activities, administrative procedure, administrative justice, controls, ineligibility and non-candidability, popular sovereignty.

Since January 2023, he has been Extraordinary Commissioner of the Italian Institute for Numismatics; previously he was Extraordinary Commissioner of the Toti Scialoja Foundation and director of the Academy of Fine Arts in Naples.
