<b>Practical-professional profile of the course and industry sector of reference</b>	<p>The course aims to train professionals to bring a <i>gender mainstreaming</i> vision to every urban and territorial Planning, design, and public policy field. Specifically, it trains experts who can address three career paths:</p> <ul style="list-style-type: none"> <li>within the professional world of architectural and urban planning firms through the acquisition of skills that make projects and plans more gender equitable;</li> <li>within the public administration realm, ensuring cross-cutting expertise in spatial regulation and <i>gender mainstreaming-inspired</i> urban and territorial policy formulation;</li> <li>in academia and research by building the foundations and providing insights for innovative paths of further study, including international ones.</li> </ul> <p>The importance of a gender-sensitive approach has also recently been reaffirmed at the European level, where The Strategy for Gender Equality 2020-2025 emphasizes the willingness and explicit call for the systematic inclusion of a gender perspective at every stage of policy development in all areas of EU action. This is a crucial inducement that, in order to be applied, requires those involved in the construction and implementation of public policies (independent of their gender) to make a conscious and responsible commitment to end gender-based violence, combat stereotypes, and fundamentally rethink living spaces, services, economies, employment opportunities, and decision-making processes. From the perspective of implementing the European Green Deal, the Commission points out that "Women and men are not affected in the same way by green policies that aim to combat climate change (women are less likely to be climate refugees) or to promote the transition to clean energy (women are more likely to be victims of energy poverty) or zero-emission transportation (it is women who use public transportation more). Addressing the gender dimension can therefore be instrumental in harnessing the full potential of these policies."</p> <p>At the end of the course, learners will have acquired the following:</p>

	<ul style="list-style-type: none"> <li>- knowledge and skills related to women's thinking, particularly in urban and environmental areas,</li> <li>- knowledge of the main policies, plans, <i>gender-sensitive</i> projects at national, European, and international levels concerning the city, living, public and neighborhood spaces, environment, and territory;</li> <li>- listening skills, critical reading of urban reality from a gender-sensitive and inclusive perspective;</li> <li>- interactive Planning and design skills.</li> </ul>

<b>Teaching methods</b>	<p>In <b>dual mode (in-person/remote)</b>, using the following methodologies</p> <ul style="list-style-type: none"> <li>- Classroom lectures,</li> <li>- seminars,</li> <li>- simulation workshops in groups,</li> <li>- field workshops,</li> <li>- project-work both in-person and remotely through the integrated use of a number of platforms (Webinar, Zoom, Meet, Webex) that allow both synchronous participation and the ability to review lectures asynchronously.</li> <li>- distance mode on a dedicated platform in synchronous and asynchronous mode</li> </ul>
