PART I – GENERAL INFORMATION

The <u>Learning Agreement</u> (LA) is the Agreement between you (as UniFi student), UNIFI and the receiving university and represents the main tool for the recognition of the learning activities undertaken during your mobility period abroad. It is an essential and mandatory document, provided for by the Erasmus+ programme in order to protect the right to the recognition of the study period carried out abroad.

Before the beginning of the mobility period, all the recipient students of an Erasmus+ mobility grant for study purposes (or of a mobility grant for double degree/joint degree) must draft the Learning Agreement together with the professor in charge of the LA for international mobility (or of the double degree/joint degree) of their own Study Course.

The Learning Agreement must include the list of the learning activities you intend to take abroad (exams, internship, thesis research, etc.) with the related ECTS credits that you wish to carry out during the Erasmus mobility and the learning activities with the corresponding CFU credits, for which you intend to request the recognition in the UNIFI career. The Learning Agreement must be approved in all its sections by the Responsible for the UNIFI LA and by the Professor/office in charge of the host University, in order to guarantee the full recognition of the learning activities in your UNIFI Study Programme.

The Learning Agreement consists of three parts which are completed during the different phases of the mobility (before, during, after):

- ✓ Learning Agreement *Before the Mobility*: it's the Learning Agreement you must present before the beginning of the mobility period;
- Learning Agreement During the Mobility Changes to the original Learning Agreement: it's any change to the initially approved Learning Agreement, you can fulfil it within 5 weeks after the beginning of the mobility period;
- ✓ Learning Agreement After the Mobility: it reports the list of the activities carried out during the mobility period released by the host University and usually replaced by a document named Transcript of Records (certification with the list of the exams completed abroad).

The Learning Agreement must be filled in through an online procedure, to be accessed from your personal **Student Career Management area GCS** with your SPID credentials.

The information contained in this document must be considered as useful general information for the Learning Agreement completion. You must carefully check any specific provisions set forth in the Regulations of your Study Course with the <u>School's International Relations Office</u>. The submission of the Learning Agreement DOES NOT in any way replace the compilation of the Study Plan, which must take place according to the deadlines and conditions set by UNIFI







PART II -BEFORE DRAFTING THE DIGITAL LEARNING AGREEMENT

Before drafting the Digital Learning Agreement, it is ESSENTIAL to carry out the following steps:

- Refer to the International Mobility web page of your UNIFI School, where you can find information on the activities you can take abroad and any restrictions of the study Courses on the choice of such activities;
- ✓ In the event of mobility for double/joint degree, scrupulously comply with the directions provided by your School regarding the activities to take abroad that you will need to include in your Learning Agreement;
- ✓ Verify on the foreign University's web pages the courses provided by the same Institution and the related syllabi (course programmes);
- ✓ With the support of the International Relations Office of your UNIFI School, after choosing the courses to attend abroad and <u>before</u> moving forward with the online filling in of the Learning Agreement, always make a **COMPARISON in terms of CFU** credits between the identified activities to take abroad and the remaining UNIFI courses of your study plan you still must sit and that you wish to replace with the exams to be taken abroad. Finally, the total number of the credits you intend to take abroad should correspond to the total number of credits of the UNIFI courses, except for different reasons which must be explained and specified in the "Notes" field (see paragraph *How to make associations*).

NB If you are in any of these situations:

✓ you are currently an undergraduate student, and you are about to graduate carrying out the mobility after enrolling in a master's degree course, and when you want to fill in the online Learning Agreement you are not yet enrolled in the master's degree program having already obtained the bachelor's degree;

OR

✓ you will carry out the mobility as a student enrolled in the master's degree but at the time of completing the learning agreement you are still enrolled in the bachelor's degree course

then you will be requested to complete initially the Learning Agreement in paper format and send it via email both to the International Relations Office of your UNIFI School and to the host institution. Once enrolled in the master's degree program, you will be able to proceed with the online application following the instructions below.

The initial screen for the completion of the Learning Agreement shows the General Data box in which you find displayed the information relating to your reference School, the data of your receiving University, the ranking status ("Avviato a destinazione" = you have accepted the location but you have not left yet, "Confermato a destinazione" = you already arrived to the host University, "Rientrato da destinazione" = you already concluded your mobility, "Rinunciato" = you have renounced the mobility), the status of your Learning Agreement and the name of your UNIFI study program Professor in charge for approving your Learning Agreement.

P.S. If the foreign university has enabled the parameter that allows the Partner to display its academic offer, you will be able to choose the activity to be taken abroad from a drop-down menu "Learning activity from the foreign university academic offer", without entering manually the data of the AD: when this will be possible, **always** check the exact description of the activity on the website of the foreign university and adopt this entry method







from the drop-down menu only if it corresponds exactly to the activity you want to take abroad. Otherwise, type the name of the AD in the editable field.

NOT ALL THE FOREIGN UNIVERSITIES HAVE ENABLED THIS PARAMETER!

d) The **dissertation work** must be included in the 'Activities to take abroad' section as "Thesis work" or "Master's Thesis work", depending on whether it is a first or second level degree dissertation preparatory work. The association with the UNIFI activity is with Final exam (Prova Finale).

Those who carry out the mobility during their PhD must specify only the activity "PhD research project" including it with zero credits.

Always state the exact name of the activity to take abroad indicating the exact number of the related **ECTS**. If the foreign university has non-ECTS credits, you must necessarily indicate these credits into ECTS adopting the necessary transformation.

Always click **Confirm** for each activity to be taken abroad.

For example, if you are enrolled in the first year of a master's degree and you are compliant with the completion of the Study Plan, you will be able to see in the list of activities from the exams record all the learning activities not yet taken in the first year, and all the free choice activities not yet taken (i.e. learning activities not associated with any year of the course, also called "free choice activities", or "TAF D"). In this case, the activities planned in the second year of the Study Plan will not be visible yet; therefore, in order to associate a learning activity to be taken abroad to a UNIFI learning activity scheduled for the following year as compared to the year of enrolment, it is necessary that you add this activity by selecting it from the Study Course academic offer.

In order to include external activities from **the last valid Study Plan** even if pertaining to the academic offer of your Study Course, you must select the related academic year (as defined by the rules for the completion of the Study Plan of your Study Course) and choose the activity among the available ones. To confirm the entry of the external activity, click on **Confirm**. To cancel, click **Cancel**.

NB! You must select the year in which the learning activity you wish to include is offered in your study plan. For example, if you started your course in the a.y. 2021/2022 and you wish to choose a learning activity scheduled for the third year according to the Study Plan, you must select the corresponding academic year (2023/2024 = 3rd year) and choose the learning activity exclusively from that year academic.

\wedge

If you included in your Learning Agreement activities relating to following years, it is necessary to wait for the publication of the new University academic offer, generally in mid-July of each year, to confirm that this activity will be activated also for the following academic year. In the event that this activity should be cancelled, it will be necessary to modify your Study Plan and, consequently, also your Learning Agreement.

c. Free choice activities (TAF D)

If your Study Course includes free-choice activities (TAF D) pertaining to the University academic offer but not to your Study Course offer, and you wish to take these activities abroad during your mobility period, you can act in one of the following ways:







Erasmus+

a) If you wish to validate the learning activity taken abroad with a free-choice activity included in the UNIFI offer, so that this will assume in your transcript the Italian name as corresponding to the UNIFI free choice exam, you should include in your Study Plan in advance the UNIFI free choice activity, so that this could be listed among the learning activities of the academic transcript being then able to associate it with the activity to take abroad when filling in the Learning Agreement. If, when filling in your Learning Agreement, you have not yet registered any course as a "free choice activity (TAF D)" in your Study Plan, you can complete the Learning Agreement by entering the corresponding activity to take abroad WITHOUT associating it - for the moment - to any UNIFI free choice activity. However, it is necessary to specify the reason for the non-association and the difference between the number of total ECTS credits (activities to take abroad) and number of total CFU credits (UNIFI activities) in the Notes addressed to the UNIFI Professor in charge of the LA. Subsequently, during the first available window, you will be able to modify the Study Plan by including the free choice activities (TAF D) / free credits in the Student's Transcript, consequently updating the Learning Agreement.

OR

b) If you wish to recognise the learning activity taken abroad as free-choice credits BUT with the foreign name, you can fill in the Learning Agreement including the corresponding activity to take abroad WITHOUT associating it - tick non-associated AD (TAF D) - to any free-choice activity included in the UNIFI academic offer. In this way, upon your return, the activity taken abroad will be recognized in your career transcript with the foreign name.

ATTENTION! This option is ALWAYS subordinated to the evaluation of the Professor in charge for the Learning Agreement's approval of your study course!

d. Degree -related research activities

During the Erasmus+ mobility for study purposes you can also carry out a degree-related research activity which must be agreed and authorized both by UNIFI and the host university. In the case of degree-related research activity it is necessary to add to the Learning Agreement the research work for the dissertation as an activity to take abroad, including the number of ECTS credits previously agreed with the UNIFI supervisor. **The agreed number of ECTS must be lower than the total number of ECTS required by your Study Plan for the final exam and must be proportional to the duration of the mobility and the expected workload**. The degree-related research activity to take abroad must be associated with the item "Final exam" in the UNIFI Student's exams record.

In order to associate the activity to take abroad and the UNIFI one, indicate "Thesis work" (if this is a degreerelated research work for the first level degree dissertation) or "Master thesis work" (if this is a degree-related research work for the second level dissertation) in the section relating to the activities to take abroad, while in the section relating to the UNIFI activities associate it with the activity relating to the final exam. You will be also asked to:

- ✓ Indicate the name and surname of the UNIFI supervisor in the Notes field (the Notes field will become available after clicking on 'Display the Learning')
- ✓ In the attachments section, you MUST enclose the <u>Declaration of degree-related research mobility</u> duly completed and signed by the UNIFI supervisor

Remember that the final exam must always be presented at UNIFI upon your return from the mobility period. **IT IS NOT POSSIBLE TO GRADUATE DURING THE ERASMUS MOBILITY**.

e. Combined internship to a period of study

The Erasmus+ mobility for study purposes may correspond to a period of study combined with a short internship, to be carried out within the host institution or in a place affiliated with the host institution. The mobility period is considered as an overall period of study. If possible, the internship should be integrated in the student's study program (*curricular internship*).

If you wish to include an internship activity in the Learning Agreement, you can specify it as an internship associating it with the curricular internship included in your study plan.

In the Notes field, you must indicate the name and the surname of the foreign Tutor who will take care for you during the internship activity, and the number of CFU credits you wish to be recognised upon return.

As a general direction, it is expected to acquire approximately 30 ECTS in one semester, and approximately 60 ECTS for a full academic year mobility. As far as recognition is concerned, it is essential to have a correspondence in terms of learning outcomes with the exams to take abroad, even if it's not necessary to have an exact correspondence in terms of ECTS between the single activity taken abroad and the single UNIFI learning activity (this is the case, for example, in which the activity taken abroad and the UNIFI learning activity are considered equivalent by the UNIFI Professor although there is a discrepancy in the number of ECTS credits of the single activities).

It is also possible to choose different kinds of associations, e.g.:

- ✓ Two exams taken abroad replace one UNIFI exam, or viceversa
- ✓ A set of exams taken abroad replace a set of UNIFI exams

Some study courses provide the possibility of choosing a set of exams previously agreed with the foreign institution: when choosing the teaching activities to be included in the Learning Agreement, always refer to the International Relations Office of your School who will support you with all the useful information.

In the recognition request, the total number of the ECTS credits in your Learning Agreement should correspond to the total number of the UNIFI learning activities you wish to be recognised, otherwise you must indicate the reason in the Notes field (e.g. foreign AD deemed equivalent to the UNIFI AD by the UNIFI Professor, even if the number of the ECTS credits related to the activity taken abroad is lower than the corresponding number of UNIFI CFU credits for the same activity).

Foreign contact management

The function 'Foreign Contact Management' (Gestisci Ref. Straniero) allows you to include/modify the foreign contact person responsible for your Learning Agreement.

through which you can:

- ✓ select the foreign contact person from a list that picks up from the external contact persons dealing with mobility issues in foreign universities. If there are no well-defined external contact persons for the receiving university, this list of values is not displayed;
- ✓ use the text fields to manually enter the contact person. Attention! You should only enter the name of the Foreign Contact Person manually if you are certain that the details of the Contact Person in your possession (first name, surname and email address) are correct. If you have any doubts, please contact the foreign office by email and inform them of the name to be entered.

If this data is not recoverable, the IT system will still be able to transmit the learning agreement to the host university, even if the field is not filled in.

It is important that you keep your Study Plan updated: even if you are carrying out your mobility period, remember to include the UNIFI activities previously included in your Learning Agreement also in your exams record (Libretto) by choosing them from your study plan offer or from the University academic offer, carrying on this procedure during the first available Study Plan compilation window set up by your UNIFI study course. Furthermore, if after updating your Study Plan it is possible to associate the activities to take abroad previously flagged as "Non-associable AD" with UNIFI activities, you must proceed with a 'Changes to the original Learning Agreement' including the association. Any modification to a Learning Agreement already approved by the UNIFI Professor will correspond to a Changes to the Original Learning Agreement. NB Before making any changes to the approved Learning Agreement, it is necessary to be sure that the Learning Agreement - Before the Mobility has been duly approved both by UNIFI and the host university.

Learning Agreement Submission

After having done the Associations and attached the Documents, if required, you can submit the Learning Agreement to the UNIFI Professor by clicking on **Submit Learning Agreement**. After clicking on **Submit Learning Agreement** and before confirming the submission of the Learning, you must specify your **level of linguistic knowledge** of the main host Institution teaching language or the level that you undertake to acquire before departure.

After the Learning submission, the UNIFI Professor automatically receives a notice on his page, **do not send other communication to the Professor or to the Offices to warn them about the submission or to solicit the Learning approval!**







After clicking on **Submit Learning Agreement**, it will be possible to fill in the Notes field for the Professor; **you must ALWAYS fill in the Notes field with these information**:

- ✓ Specify the start and end dates of the mobility (mandatory information!)
- ✓ For the School of Mathematics, Physics and Natural Sciences, confirm having first agreed on the Learning Agreement activities with the Erasmus Coordinator of your Study Course
- ✓ If you choose an activity to take abroad that counts as a MODULE of a UNIFI integrated course (this can occur, for example, if the UNIFI integrated exam does not have the same structure modules as the integrated exam in the host Institution, or if you can only attend one semester and the correspondent biannual part of the full academic year program), when associating the exam to take abroad with the UNIFI exam you will have to choose the complete UNIFI integrated learning activity always indicating in the Notes field which module of the UNIFI integrated learning activity you will take abroad and which one you will take upon your return to Florence.

NB The choice to take abroad only one part of an integrated learning activity, must not be interpreted as a routine procedure in the Learning Agreement drafting, instead of a solution to use just in cases in which it is not possible to find learning activities to take abroad totally compatible with UNIFI ones! In any case, it is always up to the UNIFI Professor and to the host institution to ultimately approve or not the Learning Agreement proposal.

- ✓ If you carry out abroad only a part of your degree-related research activity, you must specify how many CFU credits you will be carrying out abroad for this activity and the name and surname of the UNIFI Supervisor. The agreed number of ECTS must be lower than the total number of ECTS required by your Study Plan for the final dissertation and must be proportional to the duration of the mobility and the expected workload. The degree-related research activity taken abroad must be associated with the item "Final exam" and/or "Thesis research" in the UNIFI exams record (Libretto).
- ✓ If you included an activity to take abroad as TAF D WITHOUT associating it with any UNIFI free-choice activity, you must specify the reason for the non-association:

- if you haven't associated the activity because you haven't updated the Study Plan yet, during the first available window you must modify the Study Plan specifying the free choice activities (TAF D) / free credits and consequently updating also the Learning Agreement;

- if, on the other hand, you have not associated the activity because you wish it to be recognized upon return as a free-choice activity with the foreign name, specify it in the Notes field;

✓ If you have included an internship activity, also specify the name and surname of the foreign Professor as Tutor.

The different possible Learning Agreement status are:

- ✓ DRAFT (BOZZA) when it is in the process of being completed by the student. As long as the Learning Agreement is in draft status, and not presented, it cannot be viewed by the Professor;
- ✓ SUBMITTED (PRESENTATO) when the student has submitted the Learning Agreement and it is visible on the Professor's web page.

NB **Only in exceptional cases**, if following the submission, and only before the approval of the Document, you find yourself in the position of changing the already submitted Learning Agreement not yet undertaken by the Professor, you can submit a new version that will replace the previous one, by clicking on New Learning Agreement.

- ✓ REVIEW (REVISIONE) when the Professor has already undertaken the LA and he/she is in the process of reviewing it;
- ✓ INTERNALLY APPROVED (APPROVATO INTERNAMENTE) when the Professor approved the LA, even writing down some comments for the student, and it is ready for the transmission to the receiving institution and the final approval;







✓ REJECTED (RESPINTO) if the Professor rejected the Learning, writing down some comments for the student. In this case, clicking on New Learning Agreement you will be able to edit it with the revisions requested by the Professor

Transmission of the Learning Agreement to the host Institution

Since the Learning Agreement has been approved by the UNIFI Professor from his/her own webpage, it is not necessary it displays the original signature considering that it has been digitally signed.

NB the Learning Agreement *Before the mobility* must be countersigned by the host institution BEFORE the departure. If it cannot be signed before the departure **due to force majeure**, it is necessary to have it signed within 7 days from the arrival to the receiving institution.

1st sending method: UNIFI Professor' sending the Learning Agreement to the receiving institution via EWP Erasmus Without Paper node

The goal of the EWP (Erasmus Without Paper) project, in which all the European universities are involved, is the online management of the entire student mobility process, from the nomination to the "release" of the Transcript of Records. Partner universities can automatically exchange a set of information, from the generic ones related to the university, its academic programmes, offered courses, to the inter-Institutional agreements drafting, the list of nominations, mobility period data, Learning Agreement and the taken exams.

As far as the Learning Agreement is concerned, the document is sent directly from the UNIFI Professor's personal area to the Professor in charge for the receiving Institution, therefore it is not necessary for the UNIFI student to send it by email to the host Institution. Through the EWP platform, the foreign Partner can also comment on the Learning, approve or reject it. If the Learning is rejected by the receiving Institution, you will need to modify it.

If the foreign University is connected to the EWP network, you will be able to see this banner in the learning agreement compilation window

If you cannot see this banner, you must necessarily go ahead with the 2nd sending method to the receiving Institution.

Data exchange via EWP is still in an experimental not yet completed phase, given the heterogeneity of the IT implementation level of the different European universities. The online sending of the Learning to the receiving Institution by the UNIFI Professor could therefore be difficult or not feasible, in this case each student, upon notification of the International Relations Office of the School, must send the document to the host University as indicated in Modality 2

From the moment in which the UNIFI Professor clicks on the "Send via EWP" function, and until receiving the reply from the partner institution, the LA will no longer be modified either by the student or by the UNIFI Professor. In fact, the "New Learning Agreement" function will not be displayed in the student's summary page, effectively inhibiting any new operation on it.

Important! The transmission of the EWP data to the receiving Institution is carried out by the system twice a day (batch processing), the sent Learning is therefore not immediately visible to the Partner

Once examined the LA sent by the UNIFI Professor through EWP, the receiving Institution is able to run 2 procedures:

- 1. Comment on the LA: this means that there are changes to be made in order to consider your LA acceptable;
- 2. Approve the LA: the sent LA is fine and can therefore be approved by the receiving university.

Case 1: Comment received

The receiving Institution considered your LA inadmissible and proposed some changes through the comments sent. In the following image you can find highlighted an example:

The **red** box shows how, in the field of the LA summary pages named "Notes relating to the receiving university", appears the comment received which invites you to make some changes. While for the teacher what indicated in the field is just an information, for the student it has a further effect, that is to display again the function for the creation of a new LA (as highlighted in the **green** box) as you must be able to implement the required changes to get your LA approved. This will re-trigger all the internal approval process that has been described above.

Case 2: Approval received

The receiving University has approved the LA. The Notes field will contain the detail of who approved the LA and the date of approval. In the following image you can find highlighted an example:

The approval receipt from the host university allows the system to automatically generate the LA in the "Approved" status, indicating that the LA has been approved by all three Parties (student, UNIFI Professor and LA responsible for the receiving university). At this stage, the LA management process with EWP integration has concluded. You will be able to restart the process when applying 'Changes to the Learning Agreement'.

2nd method, to be used ONLY IF the 1st sending method was unsuccessful: UNIFI student sends the Learning Agreement by email to the receiving institution

If the LA sending via EWP has not been successful, i.e. the receiving institution has not received your Learning agreement via web, once the Learning has been approved by the UNIFI Professor you need to download in pdf format the European version of the document by clicking on **Print (European Standard)** and send it by email to the host University for approval and signature.

During the mobility, Changes to the original Learning Agreement

After the approval of the first Learning Agreement by the UNIFI Professor and the host University Professor, if necessary, you can make changes (so-called Changes to the original Learning Agreement). Attention! You cannot attend a course abroad and take the related exam if the activity has not previously been included in the Learning agreement: changes to the Learning agreement must be made at the beginning of the semester, not at the end!

Any changes to the original Learning Agreement already approved by both parties (UNIFI and host university) must be duly justified.

You can realize up to 4 changes to the original Learning Agreement from the first approval (internal or official).

You must complete a **New Learning Agreement** even if the first version of your Learning has been rejected by the UNIFI Professor.

We remind you that before filling in the Digital Learning Agreement, it is advisable to have previously agreed the activities to carry out abroad and to be recognised as your study plan exams with the UNIFI teacher responsible for the Learning Agreement's internal approval! The online phase approval process must not be considered as a set of "attempts", but it must be a real proposal previously shared and jointly elaborated with the responsible teacher or with the International Relations Office of the School.

In order to change the LA, you must submit a New Learning Agreement

And follow the same directions so far described, eliminating the associations already specified if you do not want to take them anymore and/or adding or deleting the activities. You must also indicate the reason for which you are requesting a change:

Even this new Learning must be approved both by the UNIFI Professor and the host university. Therefore, it's important that you act in due time before the expected return date if you wish that any new activities included in the changes will be recognised upon return. When you click on **New Learning Agreement**, the status of the Learning Agreement changes from Approved to Draft: if you change your mind and you do not intend to go forward with the changes, you can always delete the draft by clicking on **Delete draft**.

Learning Agreement History

You can always check all the approved or rejected Learnings by clicking on Learning Agreement History. The Print LA Summary mask is a useful document for internal use which shows also all the Notes written by the student and by the Professor.

After the Mobility, recognition of the activities

When completed your mobility abroad, you must contact the International Relations Office of your School and proceed with the request for recognition of the learning activities carried out abroad ONLY after having handed all the documents related to the end of your mobility.







In order to apply for the recognition of the exams taken abroad, you must first check that the last approved Learning Agreement (both by UNIFI and the host Institution) corresponds to the Transcript of Records (certification with the list of the passed exams taken abroad) provided by the host University, both relating to the names of the exams and to the number of ECTS/CFU credits. **Recognition must occur based on the last approved Learning Agreement.**

After having received the Transcript of Records in pdf copy (and the <u>Confirmation of degree-related research</u> <u>mobility</u> from the host institution, if you carried out a degree-related research mobility) and after having checked that all the passed activities are correctly registered in the Learning Agreement, you must enclose the Transcript of Records and the possible confirmation letter of degree-related research on your GCS page before asking for the recognition (section "*Upload attachments upon return*").

In the event an integration of the exam taken abroad is necessary, it is important that you register for the UNIFI integrated exam session only **AFTER** the exam recognition has been registered in the online student's exams record (Libretto)
