



Annex 2 to the Erasmus+ mobility call for traineeship year 2026/2027

Students are exempt from holding a language certification if, **at the time of application to the Call**, they meet one of the following conditions, which must be indicated in the application system in the section relating to languages:

1. They are native speakers. However, these students must hold, at the time of the Call, an appropriate certification for any other languages declared in the application, if these are neither their native language nor Italian.

2. They are enrolled in one of the degree programs taught entirely in English <https://www.unifi.it/it/studia-con-noi/corsi-di-laurea/corsi-internazionali> and indicate English as a known foreign language. For scoring purposes, however, these students must hold, at the time of the Call, an appropriate certification for any other languages declared in the application besides English, or if they declare an English proficiency level higher than that required by their degree program.

3. They have obtained a certificate attesting the successful completion of a language proficiency test at the CLA (Centro Linguistico di Ateneo), which explicitly refers to the CEFR levels (Common European Framework of Reference for Languages).

4. They have taken and passed the curricular language proficiency test (at the CLA) or the curricular exam required by their degree program (or by the bachelor's program for students enrolled in a master's degree). Curricular tests taken at the CLA are considered regardless of the test format, as determined by the agreement with the degree program.

For scoring purposes, however, these students must hold, at the time of the Call, an appropriate certification for any other languages declared that are not included in their study plan, or if they declare a proficiency level higher than that required by their degree program.

For the purposes of verifying the language requirements of the Call, language tests taken to fulfill Additional Educational Obligations (OFA) are not accepted.

5. They are enrolled in degree programs of class L-11, LM-37, LM-36 and indicate in the Call their language proficiency level corresponding to the last language exam passed within their degree program. For scoring purposes, however, these students must hold, at the time of the Call, an appropriate certification for any other languages declared that are not included in their degree program, or if they declare a proficiency level higher than that corresponding to the last language exam passed within their degree program.
6. They hold a diploma from an Italian high school with an international language option or a tourism-oriented curriculum.
7. They have obtained abroad or in Italy a high school diploma or a first- or second-cycle university degree in the language they declare to know.

The applicant must list, using the appropriate drop-down menu in the Languages section of the TURUL application, all the languages for which they are requesting a score for ranking purposes, whether they are certifications issued by external bodies (see Annex 1 to the Call for accepted certifications for the five European vehicular languages) or knowledge qualifying for exemption from certification as listed above. Scores will be awarded **ONLY** for the languages declared by the applicant during the application process.
