Art. 3 - Enrollment deadlines and ranking re-allocation procedure

Successful candidates declared winners must complete their enrollment, under penalty of exclusion, within the strict deadlines indicated below, in accordance with Art. 12 of the Call for Applications:

** Please note that the University will be closed from August 8th to August 23rd, 2026.*

Reassignments of any residual positions after the first two rounds will be activated on every Tuesday until October 27th, 2026 with a mandatory enrolment deadline set for the following Friday (11:59 PM CEST).

It is the sole responsibility of the candidates to monitor their personal applicant portal. No personal communications will be sent to candidates.

Art. 4 – Position without scholarship
