#### APPLICATION DEADLINES

Fall semester until May 10<sup>th</sup> - Spring semester until October 10<sup>th</sup>

#### INSURANCE

Students must purchase international travel insurance in order to attend Externado. Students must also purchase insurance through Universidad Externado to cover any on-campus incidents.

#### HOUSING

On-campus housing is unavailable, however Externado University has an agreement that offers 5 days of housing upon the student's arrival.

#### VISA

Less than 180-day stay: For stays of less than 6 months you do not have to apply for a study visa to enter the country. Upon entering the country, a Migration Colombia agent will put in your passport a PIP (Permiso de ingreso y Permanencia) stamp. You must request an extension of this permit before the 90 days expire. For stays longer than 6 months, all students interested in studying at the Universidad Externado, must apply for a study visa - TP3. The TP3 visa is granted to foreigners who wish to enter Colombia as part of an academic study program. This is a requirement regardless of whether or not the applicant has received a scholarship and regardless of the type of academic exchange agreement under which the applicant is entering. While the TP3 visa allows for a total length of time in Colombia of up to 5 years, the validity of each stay will depend on the timeframe authorized by the letter of invitation by the host University. The TP-3 visa will be deemed invalid if the foreigner is absent from Colombia for more than one hundred and eighty (180) consecutive days.
